Foundation Financial Report



The mission of the Lutheran Homes of SC Foundation is to support the ministry of Lutheran Homes of SC by enabling donors, who care about older adults and hospice

patients, to achieve their philanthropic goals and by being a faithful steward of their gifts. In order to fulfill this mission, we carefully oversee the management of \$42 million of endowment funds, which produce income each year. In addition to this investment income, we received contributions from 1,800 generous donors, which totaled \$775,000 this fiscal year.

There are several programs of support to the ministries of Lutheran Homes. This fiscal year, subsidized care in the amount of \$621,000 was provided to 31 residents, hospice patients and BeWell Homes Services clients who were not otherwise able to afford the full cost of their care. We were also able to assist with capital purchases, facility upgrades and medical service equipment for \$982,000. This improves the quality of life for all of those served by Lutheran Homes. Additionally, \$305,000 was distributed to supply our ministry sites with program enhancements, operational grants and support for life enrichment, pastoral care and special projects.

In total, the Foundation was able to

give \$1.9 million of support to Lutheran Homes touching all locations: Rice Estate, Trinity on Laurens, Franke at Seaside, Heritage at Lowman, RoseCrest, Lutheran Hospice and BeWell Home Services. All of this is thanks to our generous donors, past and current!



Charitable IRA Rollover



The IRA rollover offers the opportunity to give to the causes you care about without suffering adverse tax consequences. This allows some investors to transfer funds from an individual retirement account directly to a qualified charity without having to count any of that transfer as taxable income.

Individuals who own an IRA must begin taking minimum distributions at age 70 ½, and those distributions could increase

the tax liability. These dollars qualify for the provision and do not need to be included in the individual's gross income if he or she makes a "qualified charitable distribution." The charitable IRA rollover is a way to donate to charity and avoid the tax liability.

There's more to charitable giving than just the financial and tax advantages. Donors who make a gift to the Foundation have the personal satisfaction that comes from supporting Lutheran Homes and knowing they are making a difference in their respective communities. It's for all these reasons—financial, taxable, and philanthropic—that it is good to initiate a conversation about charitable giving.
